## DUNIAKU SEASON 2 TERMS & CONDITIONS

### 1. BASIC CRITERIA FOR ENTRY

The following terms and conditions apply for Carrefour Duniaku 2:

- Malaysian citizen.
- 18 years old and above.
- Academic qualification must be at least SPM / MCE.
- Working adults, fresh graduates, or even small business owners are encouraged to apply. (for business owners, you must operate the retail outlet on your own and on a full time basis).
- Possess good interpersonal skills and like to deal with people.
- Service oriented person with past experience in service industry would be an added advantage.
- Have not been declared a bankrupt.
- Must be able to manage the profitability of the outlet.

### 2. METHOD OF ENTRY

Applicants are required to complete the official 'Carrefour Duniaku 2 Application Form' which can be obtained at all Carrefour stores or downloaded from [carrefour.com.my](http://carrefour.com.my) website.

- Closing date for applications is August 10, 2008.
- Shortlisted candidates
  - will be notified via telephone and / or e-mail.
  - Shortlisted candidates will be required to attend auditions in Kuala Lumpur on the August 15 – 16, 2008.
  - will be responsible for all / any personal costs incurred in attending the auditions, including transportation to & fro the audition venue, accommodation and meals.
